Sub: Rates for utilizing the Common Bio Medical Waste Treatment Facility.

Sir,

I am directed to inform that Govt. of NCT of Delhi has approved the rates for the year 2017, w.e.f. 01/01/2017.

You are hereby directed to comply with the Bio Medical Waste Management Rules 2016 and your rates for collection, transportation, treatment and disposal of Bio-Medical Waste during 2017, w.e.f. 01/01/2017 will be as follows:-

For Nursing Homes, Hospitals and other health care establishments

- (i) Upto 7 beds- Rs.810/- (Rs. Eight hundred and ten only) per month.
- (ii) 8th beds onwards-Rs. 108/- (Rs. One hundred and eight only) per bed per month.
- (iii) Forensic labs may be charged at the rate of lowest slab of 7 beds as at (i) above declared by the Dte. General Of Health Services, GNCT of Delhi.

This issues with the approval of Competent Authority.


