A candidate should report in the office of Medical Superintendent, Jag Pravesh Chandra Hospital on the day of interview as per the schedule given in the advertisement between 9 AM and 10 AM alongwith the required documents (Photocopy & Original).

Note :

- Two posts are reserved for Physically Handicapped person as horizontal reservation of SR.
- For OBC candidate, the OBC certificate must be issued from Delhi.
- If suitable candidate of reserved category is not available then the UR category candidate will be considered on adhoc basis.

Qualification : The candidate should be MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University/Institution and should have a MBBS valid registration with Delhi Medical Council. Must have not completed 03 years Senior Residency in any recognized institution including regular and adhoc period.

Pay scale: Rs. 67700 – 208700 of level 11 plus allowances as admissible under the rules.

Age: 45 years for Gen. and OBC candidate and age relaxation for SC/ST candidate as per rule.

Tenure : The total tenure of Senior Resident is for a period of three years including any service rendered as Senior Resident earlier on Adhoc/Regular basis in any recognized institution. The appointment will be initially for 01 year that can be extended further upto a maximum period of 03 years subject to satisfactory performance, work and conduct report from concerned HOD and a written request from the doctor concerned.

Note : In case of non availability of candidates, as per the relevant criteria mentioned above, candidates may be considered under provision of relaxed criteria circulated as per circular non F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of deptt. of H & FW, GNCT of Delhi with the following relaxations :-

- In the specialties where there is perpetual shortage like Anesthesia and Radiology etc. or in specialties where no fresh candidates are available, candidates who have completed 3 years of Sr. Residency may also be allowed to appear in the interview.
- Separate merit lists for fresh candidates and for other (those who have completed 3 years of Sr. Residency already) would be prepared.
- Firstly, the list containing the names of fresh candidates would be exhausted for appointment as Senior Residents and the second list would be used only after that.
- All Senior Residents appointments from second list will be for 89 days initially & maximum for one year only.

Other conditions of Recruitment :-


1. In the specialties where there is perpetual shortage like Radiology, Anesthesia etc. or in specialties where no fresh candidates are available, candidates who have completed 03 years senior residency or candidates having experience of 02 years in the concerned specialty (Non-PG) may also be allowed to appear in the interview. The Non-PG candidates may be selected on adhoc basis only.
2. The candidates who are already in Govt. Service should submit an NOC from his / her employer.
3. A panel of wait listed candidates will be prepared for filling the post of SR for vacancies arising in future. The panel shall remain valid for 6 months or till fresh selection process is carried out whichever is earlier.
4. The services shall be governed by residency schemes of Govt. of India / Civil Services (Temporary Rules).
5. Candidates are required to bring all original certificates and testimonials with their attested photocopies along with one passport size photograph on the date of interview.
6. Candidates who are working on adhoc basis in JPCII shall have to apply afresh.
7. Appointment shall be subject to medical fitness and verification of certificates.
8. The number of vacancies may vary.
9. In case of non-availability of SC/ST/OBC candidates, the post may be filled on Adhoc Basis from other categories and vice-versa.
10. No TA/DA will be paid for appearing in the interview.
11. The decision of Selection Board / Medical Superintendent of JPC Hospital regarding selection will be final and no representation will be entertained in this regard.
12. The result of selected candidates will be displaced on the website of H&FW Deptt. GNCTD and the notice board of JPC Hospital. No individual communication will be sent to any candidate.
13. OBC / EWS candidates belonging to Delhi (Non creamy layer) will be considered for OBC / EWS seat. Candidate should have Delhi OBC (Non Creamy) and candidates applying under EWS Category must have certificate issued in 2022-23. If candidate applies under OBC/EWS category but is not able to provide valid proof of the same at the time of document verification before interview the application will be considered under UR category interview.
14. Candidature will be rejected if any discrepancy is detected in document/information at any stage of recruitment.
15. The following documents are required in original along with self attested photocopies for verification on the day of interview in the given order :-
 - i> Application in prescribed format
 - ii> Caste certificate
 - iii> EWS document
 - iv> DMC Registration (MBBS and requisite postgraduate qualification) or Acknowledgement application.
 - v> X class certificate (for date of birth)
 - vi> Degree (MBBS & Post graduate degree / DNB or Diploma)
 - vii> Aadhaar Card / Voter ID / Passport


