
Sub: Amendment in the guidelines issued for operationalizing assistance through Delhi Arogya Kosh.

In partial modification of the earlier Office Memoranda Nos. E.4125/576-586 dated 09.10.2019 & F.No. 22/25/20-GBM/8/2021/1537-40 dated 14.12.2021 regarding fixing of rates for free surgery scheme & cashless treatment to medico-legal victims of accident, acid attack, thermal burn injury & crimes in private hospitals, the Governing Body of Delhi Arogya Kosh has approved that private hospitals in NCT of Delhi shall be provided the following incentives on AB PM-JAY package rates of Health Benefit Package 2.0 (HBP 2.0) for reimbursement / payment through Delhi Arogya Kosh for free specified surgery scheme (private hospitals empanelled under DAK) & the scheme for cashless treatment of medico-legal victims of road accident, acid attack, thermal burn injury & crimes (all registered nursing homes in NCT of Delhi):

	B. Hospitals having registered bed strength of less than 100 beds irrespective of AB PM-JAY empanelment	Running PG/ DNB course in the empanelled speciality	10%	

The payment to private hospitals shall be made accordingly or the bill raised by the hospital, whichever is less.

The rates will be effective from the date of issue of this Office Memorandum.


