1. MBBS Degree recognized by National registered body.
2. Registered with Delhi Medical Council.
3. Should have completed internship within 02 years of date of interview and preference will be given to fresh candidates.
4. Non PG candidates will be preferred over PG candidates.

**Age Limit:** 30 years for General (5 years relaxable for SC/ST, 3 years relaxable for OBC and 5 years extra relaxable for Persons with disabilities candidates).

**Tenure:** The tenure of junior resident is for a period of one year only including any service rendered as junior resident earlier on ad-hoc basis in any recognized institution. The appointment will be initially for a period of 89 days or on prorata basis that can be extended further upto a maximum period of 1 year subject to satisfactory work and conduct report from concerned incharge and vigilance clearance.

3. Selected candidates shall be allowed a maximum of 07 days time accepting the offer of appointment and thereafter 07 days for joining from the date of acceptance failing which the offer shall stand cancelled.
4. The appointment will be initially for a period of 89 days purely on adhoc basis extendable up to one year.
5. Appointment shall be subject to Medical Fitness & Verification of certificates of Educational/ Age/Caste/DMC registration and internship completion certificate.
6. Candidates are required to bring all original certificates and testimonials with their attested photocopies along with two passport size photographs on the date of Interview.
