Qualification:- Post Graduate Degree (MD/MS/DNB/DIPLOMA equivalent) in concerned specialty. In Case of non availability of MD/MS/DNB/DIPLOMA Candidates, then Candidates who have at least 02 years Experience in the concerned specialty will be considered for the post and will be appointed on purely Adhoc basis for 89 days.

Age Limit:- For S.R. -45 years for General, 50 years for SC/ST and 48 years for OBC (Delhi) Candidates (as on date of interview).
