3(h). "Authorised Persons" shall be empowered to impose a fine of Rs 500/- for offence for violating the directives/guidelines pertaining to the following:

c) Wearing of Face mask/cover in all public places.

This notification shall be effective w.e.f. **28.02.2022.**

In partial modification of previous notification No. F. 51/DGHS/PH-IV/COVID-19/prsecyhfw/13087-336 dated 13.06 2020, Hon'ble Lt. Governor, Delhi is pleased to amend the clause 3(h) of The Delhi Epidemic Diseases, (Management of COVID-19) Regulations, 2020 as under:-

3(h). "Authorised Persons" shall be empowered to impose a fine of Rs 2000/- for offence for violating the directives/guidelines pertaining to the following:

- a. Observation of quarantine rules
- b. Maintaining of social distancing
- c. Wearing of Face mask/cover in all public places
- d. Prohibition of spitting in public places
- e. Prohibition on consumption of Paan, gutka, tobacco etc in public places
