Applications are invited for filling up of **06 (Six) posts of JUNIOR RESIDENTS (Dental)** at Dr. BSA Hospital. All candidates are informed to bring original document along with copy of documents (i.e marksheets of all exams of BDS course ,registration with Dental council, age, category **(Latest O.B.C certificate of Delhi)** etc, in the office of Medical Superintendent ,Dr. BSA Hospital, Sector –VI ,Rohini ,Delhi -110085.

The candidates should report for the written test (MCQ based) on **30<sup>th</sup> September, 2019 at 9.00 am** in the Office of Medical Director, Dr. BSA Hospital, Sector –VI, Rohini, Delhi -110085 for verification of original documents and admission ticket along with original Id, and one photocopy of Id. (Aadhar card/ Election Id card/ passport/ Driving license. Either of these. No other document will be accepted as valid for id purpose) No entry will be allowed after 10:15 am.

**NOTE:-**

1. Number of the posts is provisional and subject to change according to vacancies without any notice.
2. Category wise panel of wait listed candidates will be prepared for filling up the posts of JR for vacancies likely to be created /arise in future.
3. 03% seats will be reserved for differentlyabled candidates.
4. In case, SC/ST/OBC candidates are not available for the posts, the seats shall be filled up from general category candidates on Adhoc basis and vice versa.
5. In case of holiday being declared on the stipulated dates, the schedule shall get shifted to next working day or as decided by Medical Director.
6. The decision of the Selection Board /Medical Director/ Director of BSA Hospital regarding selection will be final and binding and **no representation whatsoever will be entertained in this regard.**
7. Appointment will be initially for a period of six months extendable up to maximum of one year on the basis of satisfactory Work & Conduct report from the concerned department and written request from the Doctor concerned.
8. The contract of appointment can be terminated by either party by giving a notice of one month without assigning any reason.
9. If any declaration /information furnished by the candidates are found false or any material/fact suppressed willfully, the candidature/appointment will be cancelled/terminated forthwith, due Administrative action/ legal action will be taken. Dental council of India/ State council will also be intimated for appropriate action.
10. No TA / DA shall be paid for participating in the written test / selection process.

### **Important instructions regarding filling of form :-**

1. The candidate should click on the above mentioned link, The link will be valid from date of publication of this advt. till 27th September 2019 up to 2 PM only.
2. Immediately after submitting application the candidate will receive an auto generated email.
3. The auto generated mail will be containing prefilled application form based on data submitted by the candidate. Candidate is required to bring a printout of the same along with photocopy and original Govt. issued ID card(voter card, Aadhar card, passport ,Driving license) no other ID card will be entertained.
4. Written examination (MCQ based) will be held on 30th September 2019 at 11 AM. Candidates are required to report MS office between 9 to 10 am and no entry will be allowed after 10:15 am .
5. The result of selected candidates will be displayed on hospital website and notice board. No individual communication will be sent.
6. All the shortlisted candidates will be required to get their documents verified in the hospital before joining.
7. The selected candidates are supposed to join within stipulated time.
8. Suppression of information or wrong submission of information will be liable for appropriate administrative /legal action the same will also be intimated to respective Dental council and MCI.

### **ELIGIBILITY FOR THE POST OF JUNIOR RESIDENTS (Dental):**

1. **Qualification:** BDS degree from recognized university / Institute.
  2. **Age As On Date of Interview.** Age limit is 30 years for junior resident as on date of interview and will be relaxed for SC/ST/OBC candidates as per rule.
    - a. **Pay Scale:** Shall be in accordance with 7<sup>th</sup> CPC guidelines as adopted by GNCT of Delhi.
  3. **Internship:** Must have completed one year internship on or after 30/06/2018.
  4. **Those who have already done Junior Residency in any of the Govt./ Govt aided Institution for one year are not eligible.**
  5. **Total duration of junior residency is one year irrespective of any institute. If candidate has done Junior residency from any govt./ govt aided institute, but total duration done is less than one year, then he /she is eligible for rest of the tenure so as to complete one year of Junior residency. However, under no circumstances, total duration of junior residency will exceed one year, including tenure done elsewhere.**
  6. Candidate must be registered with state dental council/ Dental Council of India.
  7. **OBC candidates belonging to Delhi (Non creamy layer only) will be considered for OBC seat. Candidate should have Delhi OBC (Non creamy) certificate issued in 2018-19.If candidate applies under OBC category but is not able to provide valid proof of the same at the time of document verification before Exam then candidature will be rejected and candidate will not be allowed to appear in exam. Change of category will not be allowed.**
  8. **Candidature will be rejected if any discrepancy is detected at any stage of recruitment in documents/ information given by the candidate.**
9. The candidates should report for the written test (MCQ) on **30th September 2019 at 9.00 am** in the Office of Medical Director, Dr. BSA Hospital, Sector –VI, Rohini, Delhi -110085 **along with all the original certificates/documents for verification. The test shall begin at 11.00 am**
10. All candidates are advised to see the notice board /Official website of the hospital for list of shortlisted / selected candidates at stipulated date and time. No letter or personal information shall be given.
