



Category	Maximum Charges
Non-Bedded Facility	Rs. 6000/- per year
a) General Practitioners (GPs)	Or Rs. 600/- per month
b) Poly clinics/Dispensaries Other than Delhi Govt.	Rs. 837/- per month
c) Forensic Labs	Rs. 837/- per month
Bedded facility	
a) 1-7	Rs. 837/- per month Upto 7 beds
b) 8 beds and above facility	Rs. 112/- per bed per month

- Rates applicable w.e.f. 01.01.2018 for the year 2018.
- Entire Biomedical Waste for Delhi Govt. Health Care Facilities continues to be free of cost as per the DPCC Order No. DPCC/WMC-I/CBWTF/2013/569-1076 dated 15.05.2015.
- In case of discontinuation of regular service of CBWTF, proportionate rates will be deducted by Health Care Facilities.
- Rates will be increased every year on 1st January as per agreement.
- In case of any complaint of overcharging, action would be initiated as per rules.
