Qualification: MBBS degree from a recognized University. Valid registration with Delhi Medical Council. Must not have completed one year Junior Residency in any recognized institution including regular & adhoc period.

Pay scale: Rs.56100 – 177500 of level 10 plus allowances as admissible under the rules.

Age: 30 years for Gen, 35 years for SC/ST and 33 years for OBC candidates on the closing date of submission of application.

Other conditions of Recruitment: -

1. The services shall be governed by residency schemes of Govt. of India. /Civil Services (Temporary Rules).
2. Candidates are required to bring all original certificates and testimonials with their attested photocopies along with one passport size photograph on the date of interview.
3. Appointment shall be subject to medical fitness & verification of certificates.
4. No TA/DA will be paid for appearing in the interview.
5. The number of vacancies of JRs may vary.
