CIRCULAR

Sub: Suspension of Dr Bhawna Anand (Delhi Medical Council Registration No. 36247) for period of 30 days w.e.f 27.03.2020.

This Directorate is in a receipt of Order No. DMC/DC/F.14/Comp.1865/2/2020/288232 dated 27.01.2020 issued by Dr. Girish Tyagi, Secretary, Delhi Medical Council in reference to complaint of Sh. Th. Mahendro Singh r/o A-9, 2nd Floor, Sanwal Nagar (Near Sadiq Nagar), South Delhi - 110049, alleging medical negligence on the part of Dr. Bhavna Anand, Dr. Bandana Sodhi in the treatment administered to complainant's wife Smt. Th. Jenita Devi at Moolchand Hospital, Lajpat Nagar- III, New Delhi - 110024. In the said order it was mentioned that

"... The Council directed that the name of Dr. Bhavna Anand (Delhi Medical Council Registration No. 36247) be removed from the State Medical Register of the Delhi Medical Council for a period of 30 days with a direction that she should undergo 30 hrs of Continuing Medical Education (C. M. E.) on the subject of Level- II Fetal USG Scan' within a period of three months and submit a compliance report to this effect to the Delhi Medical Council.....'.

"... Order direction the removal of name from the State Medical Register of Delhi Medical Council shall come in to effect after 30 days from the date of the Order...'.

The keepers of all registered nursing homes and private hospitals, situated in NCT of Delhi, are hereby directed to not allow him to practice in their nursing home / private hospital. Failure of the same shall be viewed seriously and action, as deemed fit, would be initiated against the defaulter nursing home / hospitals.
