ORDER

It has been informed by M/s Mylan Laboratories Ltd. That some of the hospital has not taken the injections allocated to them vide earlier orders and they have 476 vials of injection has left over in their stock. It was decided to allocate these left over stock among the government/Private hospitals excluding the Central Institution which have 07 patients or more so that the hospital should get at least 06 vials.

Therefore, in continuation to order of even No Dated 28.05.2021, dated 01.06.202, Dated 02.06.2021, dated 7.06.2021, dated 10.06.2021, dated 11.06.2021, 14/06/2021 and 15/06/2021 as per the revised guideline for distribution of Liposomal Amphotericin B injection on pro-rata basis of stock left over with M/s Mylan Laboratories Ltd. and total number of "under treatment" patients as on 15/06/2021 as per the Covid Portal of Govt of India (www.covid19.nhp.gov.in), the distribution has been worked out for 476 Liposomal Amphotercin-B injections.
