**OFFICE ORDER**

1. On recommendation by the Delhi Subordinate Service Selection Board, (DSSSB) Ms./Mrs. Sony, Roll No. 11250900670, was nominated for the post of Nursing officer under post code 03/18 and allotted GTB Hospital for her joining. Consequently, vide letter dated 19.08.2020, an offer of appointment letter was issued to Ms./Mrs. Sony for its acceptance, which was accepted by her vide letter dated 31.08.2020.
2. After medical examination, Ms./Mrs. Sony was directed to join duty in Guru Teg Bahadur Hospital, Govt. of NCT of Delhi within 15 days vide letter dated 10.10.2020. However, vide letter dated 27.10.2020 she has requested for extension of joining and after approval of the Competent Authority, relaxation has been given for joining on or before 15.12.2020, when no communication was received in this regard, a final opportunity was given to Ms./Mrs. Sony, vide letter dated 20.01.2021, to join this hospital on or before 30.01.2021. But till date, she neither reported to this hospital nor sent any communication in this regard. It appears that, she is not interested to join for the post of Nursing officer offered to her.
